**AN ORDINANCE APPROVING THE CONSOLIDATION OF LOT A & B, PLAT NO. 1
RECORDED IN PLAT BOOK 142 PAGE 99 ALSO KNOWN AS 9040 FROST AVENUE
AND 9080 FROST AVENUE, IN THE CITY OF BERKELEY, MISSOURI, SAINT LOUIS
COUNTY**

WHEREAS, the City has enacted a Subdivision Ordinance; and

WHEREAS, in accordance with the Subdivision Regulations, the City Plan Commission recommended approval to the City Council with conditions, to consolidate Lots A & B, Plat No. 1 recorded in Plat Book 142 Page 99, St. Louis County Records and Being Part of U.S. Survey 2 in the N. W. Fract. Quarter of Section 4, Township 46 North, Range 6 East, also known as 9040 Frost Avenue and 9080 Frost Avenue, in the City of Berkeley, Missouri, Saint Louis County; and

WHEREAS, the consolidation is to accommodate a single owner to construct a 13,300 square foot commercial operations site to provide a customer service hub for service call and dispatch center for the Missouri American Water Company at 9040 and 9080 Frost Avenue location and to allow for employee and service vehicle parking and equipment at this lot location.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BERKELEY, MISSOURI, AS FOLLOWS:

Section 1. The Lot Consolidation of Lots A & B, Plat No. 1 recorded in Plat Book 142 Page 99, St. Louis County Records and as approved by the City Plan Commission on February 12, 2020, is hereby approved by the Council of the City of Berkeley.

Section 2. The Lot Consolidation Plat and additional conditions is attached hereto and incorporated herein as Exhibit A.

Section 3. This Ordinance shall be in full force and effect upon its passage.
