AN ORDINANCE APPROVING THE REIMBURSEMENT TO TOM KIELY FOR ASPHALT PARKING LOT REPAIRS COMPLETED UNDER THE CITY'S FAÇADE PROGRAM AT 8233 AIRPORT ROAD, A SINGLE-STORY MULTI USE COMMERCIAL BUILDING IN THE CITY OF BERKELEY, ST. LOUIS COUNTY, MO

**WHEREAS,** the City Manager has determined that Tom Kiely, owner of 8233 Airport made certain repairs, and provided receipts for said repairs, and is entitled to a reimbursement in the amount of \$10,000.

## Section 1. Assistance Available

Approved projects are eligible to receive reimbursement after project completion in the form of a matching grant of up to 50 percent of the actual improvement costs up to a maximum grant of \$10,000.

#### Section 2. Authorization

The City Council authorizes reimbursement to Tom Kiely for reimbursement under the City's Façade Program for improvements to 8233 Airport Road, a single-story building in the City of Berkeley, St. Louis County, Missouri.

Project Costs - \$22,020.00

Reimbursement Amount - \$10,000.00
