AN ORDINANCE FOR THE CITY OF BERKELEY MISSOURI RENAMING EDGEWOOD PARK AT 4003 MCKIBBON ROAD TO MONTGOMERY COMMUNITY PARK

WHEREAS, Edgewood Park was acquired in 1965 by the City of Berkeley and has been used continuously as a public park; and

WHEREAS, the City Council, in recognition and honor is desirous of renaming Edgewood Park to Montgomery Community Park; and

WHEREAS, the City Council will work to have a monument installed at this park dedicating it to Jean Montgomery, the first women to be elected as Mayor of the City of Berkeley. She was dedicated to the city's progress and promoted civility in government wherever she served.

Now, Therefore, Be it ordained by the City Council of the City of Berkeley, Missouri, as follows:

Section 1. The City shall erect signage, in appropriate locations, reflecting the name and existence of the Montgomery Community Park, and may otherwise refer to the Park as such. All references to this park (or as a defined term as "Park") in City ordinances, resolutions, grants. and other laws of the City are hereby amended to reflect the said renaming to Montgomery Community Park, see EXHIBIT A.
