**AN ORDINANCE OF THE CITY OF BERKELEY, MISSOURI, REPEALING
ORDINANCE 4464 RENAMING JACKSON PARK AT 8435 AIRPORT ROAD TO LEE
ETTA HOSKINS COMMUNITY PARK**

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BERKELEY,
MISSOURI, AS FOLLOWS:**

Section 1. Ordinance 4464 “Renaming Jackson Park at 8435 Airport Road to Lee Etta Hoskins Community Park”, received final passage by the Council on May 21, 2018, is hereby repealed.

Section 2. The City shall erect signage, in appropriate locations, reflecting the name changes and existence of the Jackson Park, and may otherwise refer to the Park as such. All references to the parks (or as a defined term as “Park”) in City ordinances, resolutions, grants and other laws of the City are hereby amended to reflect the said renaming to Jackson Park.

Section 3. This Ordinance shall be in full force and effect from and after its passage.

AN ORDINANCE FOR THE CITY OF BERKELEY MISSOURI RENAMING JACKSON PARK AT 8435 AIRPORT ROAD TO LEE ETTA HOSKINS COMMUNITY PARK

WHEREAS, Jackson Park was acquired in 1960 by the City of Berkeley and has been used continuously as a public park; and

WHEREAS, the City Council, in recognition and honor is desirous of renaming Jackson Park to Lee Etta Hoskins Community Park; and

WHEREAS, the City Council will work to have a monument installed at this park dedicating it to Lee Etta Hoskins, Councilwoman Ward III, who has worked tirelessly with the City of Berkeley, serving sixteen years on the Council and six years on the Betterment Commission.

Now, Therefore, Be it ordained by the City Council of the City of Berkeley, Missouri, as follows:

Section 1. The City shall erect signage, in appropriate locations, reflecting the name and existence of the Lee Etta Hoskins Community Park, and may otherwise refer to the Park as such. All references to this park (or as a defined term as "Park") in City ordinances, resolutions, grants, and other laws of the City are hereby amended to reflect the said renaming to Lee Etta Hoskins Community Park, see **EXHIBIT A**.

Section 2. This Ordinance shall be in full force and effect from and after its passage.


