**AN ORDINANCE OF THE CITY OF BERKELEY, MISSOURI, REPEALING
ORDINANCE 4465 RENAMING MIDWOOD PARK AT 6908 MIDWOOD AVENUE TO
MITCHELL NEIGHBORHOOD PARK**

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BERKELEY,
MISSOURI, AS FOLLOWS:**

Section 1. Ordinance 4465 “Renaming Midwood Park at 6908 Midwood Avenue to Mitchell Neighborhood Park”, received final passage by the Council on May 21, 2018, is hereby repealed.

Section 2. The City shall erect signage, in appropriate locations, reflecting the name changes and existence of the Midwood Park, and may otherwise refer to the Park as such. All references to the parks (or as a defined term as “Park”) in City ordinances, resolutions, grants and other laws of the City are hereby amended to reflect the said renaming to Midwood Park.

Section 3. This Ordinance shall be in full force and effect from and after its passage.

AN ORDINANCE FOR THE CITY OF BERKELEY MISSOURI RENAMING MIDWOOD PARK AT 6908 MIDWOOD AVENUE TO MITCHELL NEIGHBORHOOD PARK

WHEREAS, Midwood Park was acquired in 1960 by the City of Berkeley and has been used continuously as a public park; and

WHEREAS, the City Council, in recognition and honor is desirous of renaming Midwood Park to Mitchell Neighborhood Park; and

WHEREAS, the City Council will work to have a monument installed at this park dedicating it to Emmalene Mitchell, Councilwoman Ward I, who has worked to rebuild this park as an inclusive park, allowing those with disabilities to enjoy park seating and play.

Now, Therefore, Be it ordained by the City Council of the City of Berkeley, Missouri, as follows:


Section 1. The City shall erect signage, in appropriate locations, reflecting the name and existence of the Mitchell Neighborhood Park, and may otherwise refer to the Park as such. All references to this park (or as a defined term as "Park") in City ordinances, resolutions, grants, and other laws of the City are hereby amended to reflect the said renaming to Mitchell Neighborhood Park, see **EXHIBIT A**.


