AN ORDINANCE FOR THE CITY OF BERKELEY MISSOURI RENAMING RAMONA LAKE PARK AT 8940 RAMONA LAKE TO LOUVENIA MATHISON COMMUNITY LAKE PARK

WHEREAS, Ramona Lake was acquired in 1969 by the City of Berkeley and has been used continuously as a public park; and

WHEREAS, the City Council, in recognition and honor is desirous of renaming Ramona Lake to Louvenia Mathison Community Lake Park; and
