**AN ORDINANCE OF THE CITY OF BERKELEY, MISSOURI, AMENDING  
ORDINANCE 4466 RENAMING LOUVENIA MATHISON COMMUNITY LAKE PARK  
AT 8940 RAMONA LAKE TO RAMONA-MATHISON LAKE PARK**

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BERKELEY,  
MISSOURI, AS FOLLOWS:**

**Section 1.** Ordinance 4466 “Renaming Ramona Lake Park at 8940 Ramona Lake to Louvenia Mathison Community Lake Park”, received final passage by the Council on May 21, 2018, is hereby amended as followed:

- Rename Louvenia Mathison Community Lake Park to Ramona-Mathison Lake Park.

**Section 2.** The City shall erect signage, in appropriate locations, reflecting the name changes and existence of the Ramona-Mathison Lake Park, and may otherwise refer to the Park as such. All references to the parks (or as a defined term as “Park”) in City ordinances, resolutions, grants and other laws of the City are hereby amended to reflect the said renaming to Ramona-Mathison Lake Park.

**Section 3.** This Ordinance shall be in full force and effect from and after its passage.

**AN ORDINANCE FOR THE CITY OF BERKELEY MISSOURI RENAMING RAMONA LAKE PARK AT 8940 RAMONA LAKE TO LOUVENIA MATHISON COMMUNITY LAKE PARK**

**WHEREAS**, Ramona Lake was acquired in 1969 by the City of Berkeley and has been used continuously as a public park; and

**WHEREAS**, the City Council, in recognition and honor is desirous of renaming Ramona Lake to Louvenia Mathison Community Lake Park; and

**WHEREAS**, the City Council will work to have a monument installed at this park dedicating it to Louvenia Mathison, Councilwoman Ward IV, who has served on the City Council for more than twenty-six years; and eighteen years on the Park Board, and five years on the Berkeley Home Improvement Committee.

**Now, Therefore, Be it ordained by the City Council of the City of Berkeley, Missouri, as follows:**


**Section 1.** The City shall erect signage, in appropriate locations, reflecting the name and existence of the Louvenia Mathison Community Lake Park, and may otherwise refer to the Park as such. All references to this park (or as a defined term as "Park") in City ordinances, resolutions, grants, and other laws of the City are hereby amended to reflect the said renaming to Louvenia Mathison Community Lake Park, see **EXHIBIT A**.

**Section 2.** This Ordinance shall be in full force and effect from and after its passage.


