## AN ORDINANCE FOR THE CITY OF BERKELEY MISSOURI NAMING 8098 ZOE DRIVE TO WILLIAMS POCKET PARK

WHEREAS, 8098 Zoe Drive was acquired in 2014 by the City of Berkeley as vacant land; and was zoned Park Land on April 17, 2018 under Ordinance #4451; and

**WHEREAS**, the City Council, in recognition and honor is desirous of naming 8098 Zoe to Williams Pocket Park; and

**WHEREAS**, the City Council will work to have a monument installed at this park dedicating it to Brenda Williams, Councilwoman Ward II, for her dedication in creating this Park for the residents of Ward Two. Councilwoman serves faithfully on the Betterment Commission beautifying the city for over seventeen years.

Now, Therefore, Be it ordained by the City Council of the City of Berkeley, Missouri, as follows:
