AN ORDINANCE OF THE CITY OF BERKELEY, MISSOURI, LEVYING SPECIAL TAX BILLS AGAINST CERTAIN PROPERTIES FOR COSTS OF CUTTING AND REMOVING WEEDS

- **WHEREAS,** the Municipal Code of the City of Berkeley, Missouri: Weeds: weeds on lots and tracts of land within the limits of the City of Berkeley in excess of nine inches (9") are declared to be a nuisance: and
- **WHEREAS,** the Municipal Code of the City of Berkeley, Missouri, provides that whenever weeds and grass are allowed to grow in excess of nine inches (9") on any part of any lot or ground within the city, the owner or owners thereof shall be liable; and
- WHEREAS, if such weeds are not cut and removed in a proper manner as required in the Municipal Code of the City of Berkeley, Missouri, a Police, Officer, City Inspector or any designated officer of the City, after notice to the owner or occupant has been given shall proceed to have such weeds cut and removed, and shall keep a record of the expense involved, and shall certify the cost of cutting removing of such weeks to the City Clerk who shall cause a special tax bill therefore against the property to be prepared and to be collected by the County Collector with other taxes assessed against the property; and
- **WHEREAS,** upon completion of the said public work, the City Council shall, by ordinance, direct the issuance of the special tax bill, which shall become a lien on the property charged therewith.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BERKELEY, MISSOURI, AS FOLLOWS:

- Section 1. The City Council hereby finds that due and proper notice was given to the parties required to be notified as required in the municipal code of the City of Berkeley, Missouri, that a nuisance was declared and ordered to be abated; that the nuisance was not abated within the time provided within said notice; that Public Works did cause said nuisances to be abated by the cutting of the weeds and grass and the removal thereof; and that Public Works has certified to the Council the cost of cutting and removing said weeds and grass from the following lots and tracts of land within the limits of the City of Berkeley that were declared to be a nuisance and not abated as required by Ordinance as set forth herein.
- **Section 2.** For the purpose of paying the cost of cutting and removing the weeds and the cost of processing special tax bills for such work as set forth, there shall be, and there is hereby, levied a special tax bill on all lots hereinafter set forth as follows:

- Section 3. The special tax bills herein levied shall be prepared and delivered to the party(ies) entitled hereto; and all such special tax bills shall bear interest at the rate of 12% per annum from and after thirty (30) days after the date of issuance. All such tax bills may be assigned and collectible in an action brought in the name of the City of Berkeley to the use of the holder thereof (but the City shall not, in any event, be liable for any costs that may accrue in such action).
- **Section 4.** All special bills issued hereunder shall be prima facia evidence of what they contain and of their validity, and no mere formality or clerical mistake in their preparation or execution or in any of the proceedings by which they were authorized will be a defense.
- **Section 5**. The tax bills authorized to be issued hereunder shall become a lien upon the property charged therewith; provided however, that there shall be no priority among the special tax bills issued here under, regardless of the date of the bills.

- Any owner of property against which tax bills herein are levied shall have the privilege of paying the full amount of tax charged against the property as aforesaid at any time before the actual issuance of the special tax bills, without interest, and in case payments are so made, no special tax bills shall be issued.
- Section 7. Upon issuance and delivery to the party of parties entitled hereto, all tax bill issued hereunder shall be registered in the office of the Director of Finance of the City of Berkeley. The record of such registration shall show the date and amount of each tax bill, the name of the parties to whom issued, a description of the property against which it is issued, that it bears interest at the rate of 12% per annum, and that it was issued for the board up, cutting of grass and weeds, or clean-up of any kind on the property against which issued. When any tax bill issued hereunder shall have been paid, it shall be marked "Paid" and surrendered to the person paying the same, and satisfaction of said tax bill shall be marked in said record of registration.
- **Section 8.** This ordinance shall be in full force and effect from and after the date of its passage and approval.
