## FOURTH AMENDMENT TO THE REFUSE COLLECTION CONTRACT

This Fourth Amendment to Refuse Collection Contract (this "Amendment") is dated effective the 1<sup>st</sup> day of January 2023 (the "Effective Date"), between **Allied Services**, **LLC dba Republic Services of Bridgeton** ("Hauler") and **City of Berkeley** ("City") (collectively referred to herein as the "Parties" and individually as a "Party").

WHEREAS, Hauler and City are parties to Refuse Collection Contract dated August 20, 2012, as may be previously amended vide Amendments dated 22nd August 2017, 1st October 2020 and 1st October, 2022 (hereinafter collectively referred to as "Contract") to provide certain services in accordance with the Contract;

**AND WHEREAS**, the Parties now desire to amend the bulk service of the Contract which shall take effect from January 1, 2023.

**NOW, THEREFORE,** for good and valuable consideration, the receipt and sufficiency of which the parties acknowledge, the parties agree to the following terms and conditions:
