





- ✓ A topographic survey of the site for all locations shown in Exhibits 1-3 for use as a map of existing site conditions prior to improvements.
- Construction Staking This will be performed when final construction plans are approved by the City of Berkeley. This will include building corners, sidewalks and curbs, sewer lines, fencing, and grading/light standards.
- ✓ All items will be staked ONCE at time of construction re-stakes will be at a T&M rate.
 - Excluded boundary and topographic information for the entire park is not included.
 - Private utility locates are not included.

2. Civil & Electrical Engineering Tasks

The civil site and electrical design will include the following:

Jackson Park:

- Removal of the existing four (4) basketball courts and one (1) volleyball court's pavement, fencing, and lighting.
- Construct 2 professional and 2 high school sized courts.
- Construct a concrete fitness court per provide specs at Jackson Park.
- Install new fencing.
- Install new lighting and wiring conduits to an existing power source to be determined.
- Relocate the storm drainage inlet and the associated piping.

Frostwood Park:

- Removal and replacement of the existing pavement for the two (2) tennis courts, removal and replacement of the existing fence, installation of new lighting and wiring conduits to an existing power source to be determined (currently there are no lights) and construct a new walkway to connect the existing walkway to the tennis courts.
- Removal and replacement of the existing pavement for one (1) basketball court, installation of new lighting, installation of a new fence along the north side of the basketball court and construct a new walkway to connect the existing walkway to the basketball court.
- Construct parking lot (20 parking spaces).
- Install speed bumps north and south of the proposed crosswalks on Evergreen Blvd.
- Install a crosswalk on Evergreen Blvd where people accessing the pool from the proposed parking lot and vice versa.

Independence Park:

- Removal of the existing pavement for the three (3) tennis courts, construction of one (1) professional and one (1) high school sized basketball courts, removal and replacement of the existing fence, removal and replacement of the existing lighting, construction of parking spaces, and construction of walkway between the existing walkways.
- Removal and replacement of the existing pavement for one (1) basketball court and the installation

- 6) Perform parking lot design.
- 7) Perform fencing design.
- 8) Perform sidewalks and walkways design.
- 9) Perform pavement design.
- 10) Prepare utility relocation plan for the storm inlet and piping due to the increase in the number of the basketball courts at Jackson Park.
- 11) Prepare specifications for the civil site work.
- 12) Prepare quantity take-offs and cost estimate.
- 13) Perform QC/QA of the design documents.
- 14) Submit plans to the City of Berkeley for review.

- 2) Site visits to assess existing conditions and to support the design layout.
- 3) Three (3) meetings with the Client/Owner on this project.
- 4) Review City of Berkeley as-built drawings for the underground electrical supply lines to the existing

- 7) Prepare quantity take-offs and cost estimate.
- 8) Perform QC/QA of the design documents.
- 9) Submit plans to the City of Berkeley for review.

- 12. Electricity meters
- 13. Utility Relocations








Tentative Schedule
