A RESOLUTION OF THE COUNCIL OF THE CITY OF BERKELEY, AUTHORIZING THE MAYOR TO EXECUTE ROAD & BRIDGE TAX COLLECTIONS AFFIDAVIT

WHEREAS, an affidavit is required to be forwarded to the St. Louis County Revenue office before the County can distribute the funds that are collected from the Road & Bridge Tax to the City of Berkeley.

- SECTION 1. The City Council hereby authorizes the Mayor to sign and execute the affidavit approving the distribution of road and bridge tax collections provided under RSMo. Section 137.558(3) to be received for the year 2023.
- **SECTION 2.** Funds shall be used for the improvement and repair of public roads, streets and bridges within the City of Berkeley lying within St. Louis County, Missouri.
- **SECTION 3.** The affidavit will be incorporated and made a part of this resolution, as if fully set out herein.
- **SECTION 4.** This Resolution shall be in full force and effect from and after the date of its passage.
