AN ORDINANCE ORDERING THE LEVY AND FIXING THE RATE OF TAXES TO BE COLLECTED IN THE CITY OF BERKELEY, MISSOURI, FOR THE FISCAL YEAR 2023/2024, TO PROVIDE FOR THE GENERAL REVENUE; ESTABLISHMENT AND MAINTENANCE OF PUBLIC PARKS; AND TO PROVIDE FOR THE PAYMENT OF INTEREST AND PRINCIPAL ON ALL OUTSTANDING BONDS OF THE CITY OF BERKELEY, MISSOURI

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BERKELEY, MISSOURI, as follows:

Section 1. There is hereby levied on all real, personal, and other property subject to taxation in the City of Berkeley, Missouri, for general purposes for the Fiscal Year 2023/2024, a tax rate as follows on each one hundred dollars (\$100) of assessed valuation of such property, as shown by the assessment books of St. Louis County, as corrected or amended by the Board of Equalization or by the State Tax Commission, and certified to by the County Clerk:

Section 2. There is hereby levied on all real, personal, and other property subject to taxation in the City of Berkeley, Missouri, to provide for principal and interest on the debt service for the Fiscal Year 2023/2024 a tax rate as follows on each one hundred dollars (\$100) of assessed valuation of such property, as shown by the assessment books of St. Louis County, as corrected or amended by the Board of Equalization or by the State Tax Commission, and certified to by the County Clerk:

There is hereby levied on all real, personal, and other property subject to taxation in the City of Berkeley, Missouri, to provide for the fire and policemen's pension fund for the Fiscal Year 2023/2024, a tax rate as follows on each one hundred (\$100) of assessed valuation of such property, as shown by the assessment books of St. Louis County, as corrected or amended by the Board of Equalization or by the State Tax Commission, and certified to by the County Clerk:

2023/2024 a tax rate as follows on each one hundred dollars (\$100) of assessed valuation of such property, as shown by the assessment books of St. Louis County, as corrected or amended by the Board of Equalization or by the State Tax commission, and certified to by the County Clerk:
