RE: Selection of Planned Design Studio to Undertake the Parks Master plan.

The Parks and Recreation Department thoroughly vetted the responses to our RFQ (request for qualifications) for a Parks Master Plan consultant, and we are prepared to recommend Planned Design Studio as the winning bidder.

The RFQ was published in October, with a response deadline of October 20th. We received two good bids, both from local firms, with proposed fees between \$48,000 and \$68,000, and both proposing a timeframe of 6 to 12 months for completion of the plan. The Parks and Recreation Department then conducted phone interviews with prior and current clients for references. They came highly recommended for skill and reliability, with references using them for multiple projects in the past and present. In the end, the Parks and Recreation Department conclude that Planning Design Studio has the best bid for the following reasons:

- They have the lowest quoted fee (\$48,000).
- They are a fully integrated design firm, covering all aspects of community development in-house, from engagement, design, financing, and implementation.
- Their history of projects closely resembles the view and outlook that is wanted and needed in the parks planning.
- Exemplary reviews from references and passion for their work.

Ultimately either of the two finalists would do a good job addressing the City's needs and wants for the parks. However, Planning Design Studio has the skills, resources, reputation, local connections, and the lowest bid to create the Parks Master Plan. In closing, we strongly recommend the City hire them as our Parks Master planning consultant.
