WHEREAS, the City of Berkeley, Missouri deems it necessary to make additional improvement to Frost Park and create a dog park on the property; to serve its citizens as well as those in the metropolitan area.

THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BERKELEY, MISSOURI AS FOLLOWS:

- **Section 1.** The Parks and Recreation Coordinator attended the Grant Workshop on Thursday, June 27, 2024 at Maryland Heights Council Chambers.
- Section 2. A single application will be made to the Municipal Park Grant Commission of Saint Louis County for Round 25 for a grant-in-aid for all of the cost for a dog park to be built at Frost Park dependent upon full grant award and reimbursable by the Municipal Parks Grant Commission upon completion by the city.
- **Section 3.** That individual project proposals are to be prepared and submitted to the Municipal Park Grant Commission on-line submission no later than the fourth Friday in August 2024.
- **Section 4.** The City Council hereby authorizes the Mayor to sign and execute the necessary documents for forwarding the project proposal applications and later execute the agreements for a grant-in-aid from the Municipal Park Grant Commission.
- **Section 5.** If a grant is awarded, the City of Berkeley will enter into an agreement or contract with the Commission regarding said grant.
- **Section 6.** This Resolution shall be in full force and effect from and after the date of its passage.

The Parks and Recreation department is applying for the Municipal Parks Grant Round 25 for the Fiscal year 2024-2025. The Parks and Recreation department has further improvements and construction of a dog park at Frost Park.

The Parks and Recreation Department has received a cost estimate from E. Meier Contracting for the cost of parts and installation of asphalt, parking, fencing, gravel, and retaining wall. The completion of the construction would only be done upon receiving the grant award. An additional \$50,000 estimate on a retaining wall for the dog park surfacing is included in the below pricing. New Asphalt Installation (6"/3"): 92 SY

- Excavate existing grass area to add space for parking stalls. Remove all debris from site.
- Install 6" compacted Type 1" Minus aggregate base course.
- Install 3" compacted Type BP-1 hot mix asphalt surface course.

Remove and Replace Asphalt Entrance: 44 SY

- Sawcut and excavate existing asphalt entrance to allow for a smooth transition into parking lot.


