**A RESOLUTION FOR THE AUTHORIZATION OF SIGNATURES FOR THE CITY OF BERKELEY BANK ACCOUNTS**

At a regular council meeting of the Council of the City of Berkeley, Missouri, Torenzo Ford is being removed from all bank accounts. The following individuals are being approved to be authorized signers for checks & transactions on the behalf of the City of Berkeley, Missouri, for the listed bank accounts.

Under the rules of the City of Berkeley financial rules, any funds deposited to the credit with a bank or trust company may be withdrawn by TWO of the listed persons (together), on behalf of the City of Berkeley, Missouri.

The authority of the City of Berkeley is to remain irrevocable so far as the bank is concerned until it is notified in writing of the revocation of such authority and shall in writing acknowledge receipt thereof.

With the passage of this resolution, the City of Berkeley City Council gives their approved authorization.
