AN ORDINANCE PROVIDING FOR THE SUBMISSION TO THE QUALIFIED VOTERS OF THE CITY OF BERKELEY, MISSOURI AT A MUNICIPAL ELECTION ON NOVEMBER 4, 2025 FOR THE ELECTION OF THE COUNCIL PERSON OF WARD I (UNEXPIRED TERM), PROVIDING FOR THE DATE OF SUCH ELECTION, MANNER OF FILING AND VOTING AT SUCH ELECTION, AND FOR THE PUBLICATION OF NOTICE OF SAID ELECTION

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BERKELEY, MISSOURI, AS FOLLOWS:

- Section 1. There shall be submitted to the qualified voters of the City of Berkeley at a Municipal Election to be held on November 4, 2025 for the election for the Council person of Ward I. (Unexpired Term)
- Any person desiring to become a candidate shall no earlier than **Tuesday**, **July 8**, **2025**, 8:00 am and no later than **Tuesday**, **July 29**, **2025**, 5:00 pm, pay a filing fee of twenty (\$20.00) dollars and file a statement of candidacy as provided in the Charter, all with the City Clerk during regular normal working hours.
- Section 3. Proof of residency is required. All candidates for Municipal Public Office must not be delinquent in financial liabilities or obligations to the City on the day of filing statement of candidacy and day of election.
- **Section 4.** The qualified voters in the City of Berkeley will at the election on the aforesaid, vote on a ballot form to be prescribed by the St. Louis County Board of Election Commissioners in substantially the following form:

Section 5. The aforesaid Municipal Election shall be held and conducted on the date aforesaid, during the same time, at the same polling places, and in the same manner and by the same judges and clerks who conducted the Municipal Elections to be held in the State of Missouri and County of St. Louis on November 4, 2025, and the returns of said election on said candidates shall be made at the same time and in the same manner provided in the Charter of the City of Berkeley for the return, canvass, and declaration thereof. Said election shall be held in accordance with the applicable provisions of the Constitution and laws of the State of Missouri and Charter and ordinances of the City of Berkeley as they apply to Municipal Elections.

Section 6. This ordinance shall be in full force and effect from and after its passage.
