

## City of Berkeley, Missouri City Council Meeting

July 14, 2025 Minutes

## **Meeting Called to Order:**

Mayor Crawford-Graham called the council meeting to order at 7:00 pm.

Roll Call: Holmes-Aye, Williams-Aye, Hoskins-Present, Anthony-Aye, Hindeleh-Absent, and Mayor Crawford-Graham-Aye (Aye-4, Present-1) motion passed. City Clerk Jones read Bill #5084 by title. *Ordinance* #4904

After an additional personnel discussion, Councilwoman Holmes moved and Councilman Hoskins seconded the motion to have the City Manager offer a full-time position to the finance director at \$120,000. Roll Call: Holmes-Aye, Williams-Aye, Hoskins-Aye, Anthony-Aye, Hindeleh-Absent, and Mayor Crawford-Graham-Aye (Aye-5) motion passed.
