**AN ORDINANCE OF THE CITY OF BERKELEY, MISSOURI, AUTHORIZING
THE RELOCATION OF WATER SERVICES TO ONE FIRE HYDRANT**

- Section 1.** The fire hydrant highlighted and shown on Attachment 1 is hereby approved to relocate it 130’ North of its current location on James S. McDonnell Blvd.
- Section 2.** Attachment 1 is hereby incorporated herein and made a part of this ordinance, as if fully set out herein.
- Section 3.** This Ordinance shall be in full force and effect from and after its date of passage.

SUBJECT: Fire Hydrant relocation



Recommendation: Attached is a map showing the current location of the fire hydrant on James S. McDonnell (approx. 350' south of driveway for Signature Aviation). I am seeking an ordinance to relocate the fire hydrant 130' north of its current location (approx. 230' south of driveway for Signature Aviation). In order to move the existing hydrant, the water company will require an ordinance from the City as part of the water company's normal policies and procedures.

Background: This is consistent with previous work done by Missouri American Water Company for new development. This will allow the new proposed development for that area to move forward.
