

# City of Berkeley, Missouri City Council Meeting Virtual

May 2, 2022 Minutes

### **Meeting Called to Order:**

Mayor Deinbo called the council meeting to order at 1:00pm.

Roll Call:

# **Approval of the Minutes:**
