Mayor Deinbo called the meeting to order at 4:07pm and the City Clerk read the notice.

City Manager Mai-Lombardo, Finance Director Ford, HR Manager Walton, Chief Jackson, Street/Parks Supervisor White, Facility Maintenance Supervisor Hibbler, Lead Mechanic Chisolm and City Clerk Jones were in attendance.

## Budget Workshop

Mayor Deinbo opened the floor to the City Manager to discuss the budget. The City Manager discussed the Insurances, Council expenses, City Clerk expenses, Code Enforcements expenses, Finance Department expenses, and the Parks fund.

The councils travel expenses will be increased to \$2,000 each expect for the Mayor and Ward 2. The Contingency fund line item is included in the general fund. Employment advertisement will be included in a future bulletin.

Councilwoman Anthony moved, Councilwoman-at-Large Crawford-Graham seconded, and the motion carried to hold a closed session for personnel and adjourn the regular meeting. Motion passed. Meeting adjourned at 5:13pm.

Mayor Deinbo opened the closed session at 5:30pm. Roll Call: Verges-present, Williams-present, Hoskins-absent, Anthony-present, Hindeleh-present, Crawford-Graham-present, and Mayor-present. City Manager Mai-Lombardo and City Clerk Jones were in attendance.

Mayor Deinbo moved and Council Hindeleh seconded the motion to adjust the salaries as follows: Human Resource \$85,000, City Clerk \$85,000, Finance Director \$85,000, Staff Accountant current salary, City Attorney \$120,000, Information Technology \$85,000, and the rest of the employees 5% across the board. Roll Call: Verges-Aye, Williams-Aye, Hoskins-Absent, Anthony-Aye, Hindeleh-Aye, Crawford-Graham-Aye, and Mayor-Aye (Aye-6) motion passed.

Councilwoman-at-Large Crawford-Graham requested the following statement be put in the minutes: The City Clerk being in a meeting where the discussion is pertaining to her is out-of-order.

Mayor Deinbo asked the rest of the present council members if they mind if the City Clerk stayed in the meeting. There were no objections.

Councilwoman Anthony moved, Councilman Hindeleh seconded, and the motion carried to adjourn at 5:59 pm.

Mayor Deinbo called the meeting to order at 4:10pm and the City Clerk read the notice.

City Manager Mai-Lombardo, City Attorney Smith, Finance Director Ford, Chief Jackson, Chief Linhardt, Information Technology Decker, Street/Parks Supervisor White, Facility Maintenance Supervisor Hibbler, Lead Mechanic Chisolm, Planning & Economics Liebson, Court Administrator Proebsting and City Clerk Jones were in attendance.

Mayor Deinbo opened the floor to the City Manager to discuss the budget. The City Manager discussed the Economic Development expenses, Facilities Maintenance expenses, Streets Department expenses, Fleet Department expenses, Municipal Court expenses, Information Technology expenses, Police Department expenses, Fire Department expenses, and salaries.

Each director/supervisor left the meeting after their department was discussed before the council.

City Attorney Smith expressed that salaries should be discussed in open session not closed session.

Councilman Hoskins requested for a salary detail for all employees. The Council members will submit to the City Manager desired streets for the repair list. The Police and Fire Departments salaries are set by contract.

Mayor Deinbo moved and Councilman Hindeleh seconded the motion to give a 5% increase across the board excluding the Fire and Police Departments. Roll Call: Verges-Aye, Williams-Aye, Hoskins-Aye, Anthony-Aye, Hindeleh-Aye, Crawford-Graham-Aye, and Mayor-Aye (Aye-7) motion passed

Mayor Deinbo moved, Councilman Hindeleh seconded, and the motion carried to adjourn the meeting at 5:55pm.
