

# City of Berkeley, Missouri City Council Meeting

October 7, 2024 Minutes

# **Meeting Called to Order**

Mayor Deinbo called the council meeting to order at 7:22pm.

Roll Call:

Mayor Deinbo present Quorum established.

City Manager Mai-Lombardo, City Attorney Smith, Chief Jackson, Chief Linhardt, City Planning Director Liebson, Finance Director Ford, Street Supervisor White and City Clerk Jones were in attendance.

### **Approval of the Minutes:**

Councilman Hindeleh moved and Mayor Deinbo seconded the motion to approve the minutes for the 09-09-24 regular meeting and 09-24-24 special meeting with corrections. Roll Call: Williams-Aye, Hoskins-Present, Anthony-Present, Hindeleh-Aye, Crawford-Graham-Abstain, and Mayor-Aye (Aye-3) motion passed.

### **Public Hearings:**

Community Development Block Grant FY2025

Mayor Deinbo opened the CDBG Public Hearing to the council and public for questions and answers about the 2025 funds. The program has been changed to every 3 years instead of every year, which backdated to the FY2023. The 2023 funds were already allocated, so the 2025 funds include 2 years only = \$243,200. The CDBG funds along with other funding will go towards extending Wabash Ave from Tyndall to Airport Road through a portion of the old Airport School lots.

### **Citizens Hearing:**

Presentation by Tayah Jones with Inspired STL

Councilman Hoskins moved and Councilwoman Anthony seconded the motion to approve Inspired STL program with a donation of \$500 towards food and permission to use the Civic Center at no charge for Halloween event. Roll Call: Williams-Aye, Hoskins-Aye, Anthony-Aye, Hindeleh-Aye, Crawford-Graham-Aye, and Mayor-Aye (Aye-6) motion passed.

Councilman Hindeleh moved and Councilwoman Anthony seconded the motion to approve Kenndis Joy request for an openair event to hold the Kidz of Joy annual Halloween event with a portion of Madison closed on Oct 26<sup>th</sup> from 11am-4pm. Roll Call: Williams-Aye, Hoskins-Aye, Anthony-Aye, Hindeleh-Aye, Crawford-Graham-Aye, and Mayor-Aye (Aye-6) motion passed.

Political signs are not allowed to be placed on public property at intersections. They can only be put on private property with permission from the owner.
