Mayor Crawford-Graham called the special meeting to order at 11:00am by reading the notice.

Acting City Manager Walton, Interim City Attorney Ezell-Gillespie, Interim Finance Director Nelson, Fire Chief Linhardt, Police Chief Jackson, Network Information Director Decker, Code Enforcement Supervisor Burton, Court Supervisor Proebsting, and City Clerk Jones were in attendance.

Councilman Hoskins moved and Councilwoman Anthony seconded the motion to amend the agenda by adding the Introduction of Bill #5081. Roll Call: Holmes-Aye, Williams-Aye, Hoskins-Aye, Anthony-Aye, Hindeleh-Absent, and Mayor Crawford-Graham-Aye (Aye-5) motion passed.

City Clerk Jones read by title only Bill # 5081: An Ordinance Approving the Budget of the City of Berkeley, Missouri, for the Fiscal Year Commencing July 1, 2025 and Concluding June 30, 2026; Appropriating the Sums therein or the Purposes and Objects therein (Council Present).

Mayor Crawford-Graham turned the meeting over to Acting City Manager Walton. She and Interim Finance Director Nelson directed the flow of the meeting.
