

# City of Berkeley, Missouri City Council Meeting

October 20, 2025 Minutes

#### **Meeting Called to Order:**

Mayor Crawford-Graham called the council meeting to order at  $7:00~\mathrm{pm}$ .

Case PZ25-06: Shall a request for a Special Use Permit be granted to Randy Johnson for Bonehead's Bar-B-Que Restaurant to include liquor sales located at 8363 Airport Road?
