City Council Meeting
January 12, 2026
Minutes

Meeting Called to Order:

Mayor Crawford-Graham called the council meeting to order at 7:00 pm.

Roll Call:

Chief Linhardt, Attorney Boyd, Major Runge, Interim Finance Director Nelson, Public Works Secretary Campbell and City Clerk Jones were present.

Approval of the Minutes:

After a discussion about clarifying a motion during the 12-17-25 meeting, Mayor Crawford-Graham moved and Councilwoman Holmes seconded the motion to approve the 12-01-25 regular meeting minutes and the 12-17-25 special meeting minutes with corrections. Roll Call: Holmes-Aye, Williams-Aye, Hoskins-Nay, Anthony-Aye, Hindeleh-Aye, and Mayor Crawford-Graham-Aye (Aye-5, Nay-1) Motion passed. The motion to change in the 12-17-25 minutes: Councilman Hoskins moved and Councilman Hindeleh seconded the motion recommending the council will be the committee to interview and hire the applicants for the Police Chief, HR Director, and City Manager. The motion is changed to: Motion that the City Manager will provide documentation for the positions of Police Chief, HR Director, and City Manager.

Councilman Hoskins requested that the minutes show that he is challenging the vote of the motion changing what he states was his motion. Mayor Crawford-Graham states that the motion is illegal.

Councilwoman Anthony left the meeting at 7:30pm.

Councilman Hindeleh moved and Councilwoman Holmes seconded the motion to close the citizens hearing portion of the meeting. Roll Call: Holmes-Aye, Williams-Aye, Hoskins-Aye, Anthony-Absent, Hindeleh-Aye, and Mayor Crawford-Graham-Aye (Aye-5) motion passed.

Councilman Hoskins moved and Councilman Hindeleh seconded the motion to hire Curtis, Heinz, Garrett, and O’Keefe firm for Civil Service Board hearings. Roll Call: Holmes-Aye, Williams-Aye, Hoskins-Aye, Anthony-Absent, Hindeleh-Aye, and Mayor Crawford-Graham-Aye (Aye-5) motion passed.

Councilwoman Williams left the meeting at 9:29pm.

Mayor Crawford-Graham moved and Councilman Hoskins seconded the motion to make the Major acting Police Chief with a freeze on hiring / promotions / disciplinary actions unless the disciplinary involves safety actions. Roll Call: Holmes-Aye, Williams-Absent, Hoskins-Aye, Anthony-Absent, Hindeleh-Aye, and Mayor Crawford-Graham-Aye (Aye-4) motion passed.

Mayor Crawford-Graham moved and Councilman Hoskins seconded the motion that the fire and police chiefs will be acting in the role as the city manager. Due to the hiring freeze, the Police Chief will bring all hiring/firing/promotions to the Fire Chief, who will consult with the council. Roll Call: Holmes-Aye, Williams-Absent, Hoskins-Aye, Anthony-Absent, Hindeleh-Aye, and Mayor Crawford-Graham-Aye (Aye-4) motion passed.

Mayor Crawford-Graham moved, Councilwoman Holmes seconded, and the motion carried to adjourn the closed session of the meeting at 10:07 pm.
